At 8:38 a.m., Vice-Chairman Luckett announced that the MCEDA Board members present constituted a quorum, declared the meeting duly convened and directed that the notice for the meeting be filed with the minutes.

Mr. Smith made a motion to amend the agenda to show that Vice-Chairman Luckett was presiding over the meeting in Chairman Slaughter's absence. After a second by Mr. Gardner, the motion was unanimously approved.

Vice-Chairman Luckett gave brief remarks regarding MCEDA's visioning process, and advised that MCEDA was moving the process forward in the search for an Executive-Director. He further announced that the purpose of the Special Call Meeting was to have a continuation of previous discussions facilitated by Vision First on potential collaborative efforts by the MCEDA Board and the Madison County Business League & Foundation in advancing economic development in Madison County. Vice-Chairman Luckett then turned the meeting over to Gray Swoope of Vision First Advisors.

Mr. Swoope gave a brief recap of the initial facilitated discussion between the MCEDA Board and the members of the Madison County Business League & Foundation on a common purpose, and potential collaborative efforts for both organizations to support each other. Mr. Swoope then turned the meeting over to Melissa Medley.

Melissa Medley then proceeded with a facilitated discussion among those present, which included general discussion of potential collaborative efforts, potential alignment of resources, and potentially another similar meeting of MCEDA, and the MCBL&F, to be set at a later date.

No formal action was taken, and the members of the MCBL&F excused themselves.
