At 9:33 a.m., Chairman Luckett announced that the members present constituted a quorum, declared the meeting duly convened and directed that the notice for the meeting be filed with the minutes. Mr. Jones opened the meeting with a prayer.

Mr. Newman made a motion to adopt the agenda. After a second by Mr. Jones, the motion was unanimously approved.

There was a motion by Mr. Jones and a second by Mr. Smith to go into closed session for the purpose of discussing the need for an Executive Session to address legal matters with Project Phoenix. If there is no response after ten days, MCEDA will pursue litigation to resolve the matter. After a second by Mr. Jones and Mr. Jim Smith abstaining from the vote, the motion was approved.
