Mr. Smith made a motion to adopt the agenda as presented. After a second by Mr. Newman, the motion was unanimously approved.

There was a motion by Mr. Newman and second by Mr. Slaughter to go into closed session for the purpose of discussing the need for an Executive Session to address confidential discussions and negotiations regarding the location of a business in Madison County. The motion passed unanimously.
