Mr. Hutchinson made a motion that MCEDA will agree to accept a settlement amount as determined by the attorney and deemed acceptable by MCEDA Board and Gail Pittman Inc. plus legal expenses and the \$100.00 purchase fee identified in the original lease. After which, MCEDA will deed said property to Gail Pittman Inc. After a second by Mr. Estes the motion was unanimously approved.

Mr. Coursey will work with Mr. Loeb to make sure the wording and acceptable amount are correct before presenting to Gail Pittman Inc.
